The following revised motions will be voted on at the May meeting

#### **Revised Motion 1**

##### **4.0 Membership**

**Delinquent members** are members who have failed to pay their annual dues by February 28<sup>th</sup>. **Non-Members** are individuals that have either never been members of TCRCC or Delinquent members for the previous one calendar year. The Board shall notify delinquent members in February of their delinquency status. If their dues are not paid in full by the last day of February then their active membership status is **terminated** automatically. The individual will no longer have flying rights at TCRCC (except as a participant in a TCRCC event that is open to all AMA members) until membership has been renewed. **Delinquent members cannot fly as a guest. The individual will remain in delinquent status for one calendar year if dues were not paid, then moved to Non-Member status at the end of the year.** Renewal of active voting membership requires full annual dues payment regardless of the month of the year. **No quarterly pro-rate shall be provided to delinquent members unless due cause is presented in writing to the Board of Directors. Any delinquent member having for example, financial, work, family, or health issues can make an appeal to the board.**

## **Revised Motion 2**

**4.1 Late Fee** will be removed

**4.1 Late Fee** a late fee of \$30 will be charged to individuals (that were members of the previous year) that have not paid their annual dues by February 28. Any member having for example, financial/work/family/health issues can make an appeal to the board to pay dues without penalty. This will go into effect July 1, 2022.

## **Revised Motion 3**

**4.1 Membership Dues Proration**

Dues for Non-Members will be prorated quarterly at the current regular or senior rates.
